REGISTRATION FEES

Article 2 of Law 19 dated August 3^{rd} , 1992 establishes the following registration fees for vessels on international voyages:

a.	For vessels up to 2,000 GRT	\$ 500.00
b.	For vessels more than 2,000 GRT up to 5,000 GRT	\$ 2,000.00
c.	For vessels more than 5,000 GRT up to 15,000 GRT	\$ 3,000.00
d.	For vessels more than 15,000 GRT (plus \$0.10 for each GRT or fraction above 15,000 GRT a maximum total registration fee of \$6,500.00)	\$ 3,000.00

ANNUAL TAXES

Article 3 of Law No. 4 dated February 24th, 1983 establishes that all vessels on international voyages registered in the National Merchant Marine shall pay an <u>annual tax</u> of \$0.10 per NRT or fraction.

Article 4 of Law No. 4 dated February 24th, 1983 establishes that all vessels on international voyages registered in the National Merchant Marine shall pay an <u>annual consular fee</u> as follows:

a. Vessels on international voyages engaged in <u>maritime trade</u>, including general cargo, passenger ships, fishing boats, dredgers, ferry boats, tugboats and drilling units

(i)	Up to 1,000 GRT	\$ 1,200.00
(ii)	More than 1,000 GRT up to 3,000 GRT	\$ 1,800.00
(iii)	More than 3,000 GRT up to 5,000 GRT	\$ 2,000.00
(iv)	More than 5,000 GRT up to 15,000 GRT	\$ 2,700.00
(v)	More than 15,000 GRT	\$ 3,000.00

b. Vessels on international voyages without self-propulsion and ships engaged in <u>scientific research activities</u>, supply vessels, submarines, crew boats, exploration ships, floating dry-docks and other vessels engaged in <u>non-profitable and non-commercial activities</u>, except those described in the preceding paragraph:

(i)	Up to 500 GRT	\$ 850.00
(ii)	More than 500 GRT up to 1,000 GRT	\$ 1,400.00
(iii)	More than 1,000 GRT	\$ 1,800.00

c. Section 4, Article 96 of Law No. 57 dated August 6th, 2008 establishes that every

type of vessels engaged in <u>non-profitable activities dedicated to sports, private or</u> <u>pleasure</u> or else activities are allowed to be registered in the Panamanian Merchant Marine.

Article 5 of Law No. 19 dated August 3rd, 1992 establishes that such noncommercial leisure crafts should pay a rate of \$1,500.00 every two (2) years. In case that the vessels is the property of a Panamanian owner the rate will be \$1,000.00.

INSPECTION FEES

Article 5 of Law No. 4 dated February 24th, 1983 establishes that all vessels on international voyages registered in the National Merchant Marine shall pay <u>annual safety inspection fees</u> as follows:

Note: The interested parties must pay all additional expenses when the Directorate General of Merchant Marine may incur in inspections carried out in places other than those provided for such purposes. Additionally, if there is a need for extraordinary inspections or re-inspections, this provision will also apply.

CASUALTY INVESTIGATIONS FEES

Article 6 of Law No. 4 dated February 24th, 1983 establishes that all vessels on international voyages registered in the National Merchant Marine shall pay an annual rate for <u>casualty</u> investigations and for the participation of the Panama Marine Authority in international <u>conferences</u> as follows:

a. Oil tankers, drilling units, passenger vessels, gas tankers and chemical tankers \$ 8

\$ 850.00

b. Other types of vessels not specified above:

(i)	Up to 500 GRT	\$ 300.00
(ii)	More than 500 GRT up to 10,000 GRT	\$ 400.00
(iii)	More than 10,000 GRT	\$ 500.00

Above listed vessels shall pay \$0.03 per each NRT or fraction thereof.

Note: Leisure crafts not engaged in lucrative activities and vessels without self-propulsion, except drilling units, are exempted from this provision.

MODIFICATION FEES

Article 3 of Law 19 dated August 3rd, 1992 establishes that vessels on international voyages will be subject to the following fees when they incur in any modifications or alterations of the information stated in the Statutory Certificate of Register, or due to performance of administrative acts regarding documentation of such vessels:
