## **CERTIFICATES OF PROFICIENCY UNDER REGULATION 1/2**

- BASIC TRAINING FOR OIL AND CHEMICAL TANKER CARGO OPERATIONS. (REG.V/11, PAR.2.2, SECTION AV/11, PAR.1ANDTABLe AV/111).
- ADVANCED TRAINING FOR OIL TANKER CARGO OPERATIONS. (REG. V/11, PAR. 4.3, SECTION AV/11, PAR. 2 AND TABLE AV/112).
- ADVANCED TRAINING FOR CHEMICAL TANKER CARGO OPERATIONS. (REG. V/11, PAR.

## ADMINISTRATIVE REQUIREMENTS

- 1. FORM F76 (TIT) "APPLICATION FOR TECHNICAL DOCUMENTATIONS FOR SEAFARERS" DULY FILLED OUT AND SIGNED.
- 2. ORIGINAL PERSONAL IDENTITY DOCUMENT: FOR NONNATIONALS (VALID PASSPORT) / FOR PANAMANIANS (VALID PERSONAL IDENTITY CARD OR VALID PASSPORT).
- 3. CERTIFICATE OF COMPETENCY AS MASTER OR OFFICER. AND FOR RATINGS SEAMANS BOOKS OR CERTIFICATE OF PROFICIENCY
- 4. EXPERIENCE FOR THE ADVANCED CERTIFICATE OF PROFICIENCY TO APPLY:
  - 4.1. COP ADVANCED TRAINING FOR OIL TANKER CARGO OPERATIONS. (REG. V/11, PAR. 4.3, SECTION AV/11, PAR. 2 AND TABLE AV/112). AT LEAST THREE (3) MONTHS OF APPROVED SEAGOING SERVICE ON OIL TANKERS.
  - 4.2. COP ADVANCED TRAINING FOR CHEMICAL TANKER CARGO OPERATIONS. (REG. V/11, PAR. 6.3, SECTION AV/11, PAR. 3 AND TABLE AV/113). AT LEAST THREE (3) MONTHS OF APPROVED SEAGOING SERVICE ON OIL TANKERS.
  - 4.3. COP ADVANCED TRAINING FOR LIQUEFIED GAS TANKER CARGO OPERATIONS.
    (REG. V/12, PAR. 4.3, SECTION AV/12, PAR. 2 AND TABLE AV/122). AT LEAST THREE (3) MONTHS OF APPROVED SEAGOING SERVICE ON OIL TANKERS.
